As per the paper read 2nd above, orders were issued for giving honorarium to the external examiner for conducting the qualifying viva-voce examination for PG/Ph.D at a time in a Subject/Department and it was decided that the maximum amount that can be given as honorarium for the external examiner to conduct the qualifying viva-voce examination for PG or (and) Ph.D at a time in a subject/department is hereby limited to a maximum of Rs. 5000/- per day with a minimum of 6 student's viva conducted per day.

While considering the confirmation of minutes of the 132nd meeting of Academic council held on 28.09.2018, the following modifications were suggested in the Order No. Acad.B2/2018/101/16258 dtd. 22/02/2019 and the same was approved by the 133rd meeting of the Academic Council held on 26.04.2019.

"The amount that can be given as honorarium for the external examiner to conduct the qualifying viva-voce examination for PG or (and) Ph.D at a time in a subject/department is limited to a maximum of Rs. 5000/- per day per individual expert at the rate of Rs. 1,500/per student with a minimum of 6 student's viva conducted per day."

In consonance with the decision of 133rd meeting of the Academic Council held on 26.04.2019, following order is issued

The amount that can be given as honorarium for the external examiner to conduct the qualifying viva-voce examination for PG or (and) Ph.D at a time in a subject/department is hereby limited to a maximum of Rs. 5000/- per day per individual expert at the rate of Rs. 1,500/- per student with a minimum of 6 student's viva conducted per day.
