## <u>ORDER</u>

As per the order read 1<sup>st</sup> above, the clause 21.1 para II of UG regulations 2013 was amended by adding the following para to the already existing regulation.

"A student who is absent in semester final examination due to accident, hospitalization, contagious diseases and any other genuine reason recommended by the Head of Institution, but has secured minimum requirement of attendance will be awarded grade point of F (Failed) instead of I\* or I to such students to re-register the course and appear for theory and practical examinations alone".

A proposal to modify the above said regulation was placed before the 7<sup>th</sup> meeting of Board of Studies (Forestry) held on 08.03.2019. The board has approved the proposal and decided to award I\* in the particular course and the student is allowed to write the final exam separately.

The same was placed before the 133<sup>rd</sup> meeting of Academic council held on 26.04.2019, and the council has approved with the modification that "in genuine cases, the students can be provided with an F\* in the particular course and be allowed to write the final exam separately".

In consonance with the decision of the 133<sup>rd</sup> meeting of Academic council held on 26.04.2019 the clause 21.1 para II of UG regulations 2013 is hereby modified as follows.

"A student who is absent in semester final examination due to accident, hospitalization, contagious diseases and any other genuine reason recommended by the Head of Institution, but has secured minimum requirement of attendance will be awarded grade point of F\* in the particular course and be allowed to write the final exam separately".

The order read 1<sup>st</sup> above stands modified to this extent.
